Part 2 approaches the process of writing from the perspective of the text itself. And Part 3 is concerned with those spatial, temporal, and linguistic elements ("context") that surround the literary text. Robert L. Historical Pragmatics Dec 30 2019 Until very recently, pragmatics has been restricted to the analysis of contemporary spoken language while historical linguistics has studied historical texts and language change in a decontextualized way. They represent Indonesia's growing desire for a status-consistent behaviour, its response to the prevailing strategic uncertainty in the Indo-Pacific region and its attempt to advance its strategic interests. The Forests of the Congo Basin Jul 17 2021 The 2010 State of the Forest report (SOF) benefited from financial support from the European Union, the United States, Germany, France and UNESCO. It represents the collaborative effort of over 100 individuals from a diversity of institutions and the forestry administrations of the Central African countries. The SOF process began with the selection and definition of indicators relevant to monitoring the state of forests in Central Africa. The indicators are structured around three thematic areas: (i) forest cover; (ii) management of production forests; and (iii) conservation and biodiversity. They are presented in a hierarchical structure at the regional, national and management unit (i.e. logging concessions and protected areas) levels. The indicators were vetted by a representative panel of stakeholders of forest management in Central Africa. The indicators are used to guide an annual data collection process carried out between April and August by national groups of four to ten individuals working within the forestry administrations. The data reported on in the 2010 SOF were primarily collected in 2009 and 2010. Results were validated in national workshops attended by government officials as well as representatives of environmental NGOs, the private sector and development projects. The data provided an important basis for the authors of the 11 chapters of the 2010 SOF, which were under the coordination of a scientific committee of international renown. A final workshop was held 29-30 March, 2011 in Douala to review a draft report. Following amendments based on comments from a wide audience of experts the final layout was completed.

La République des mallettes Dec 22 2021 La démocratie est-elle en train de tuer la démocratie, à bas bruit ? L'actualité a égrené depuis quinze ans des scandales politico-financiers sans que nous ne puissions en comprendre la logique, s'il devait même y en avoir une. Après plus d'un an d'enquête, au cours de laquelle de très nombreux acteurs, jusqu'au sommet de l'État, ont accepté de lui parler, à condition que cela soit souvent en « off », Pierre Péan met au jour bien des aspects passés inaperçus sur les activités dans les zones grises de l'État. Dans toutes ces affaires, un seul enjeu : constituer un « trésor de guerre », en vue de la campagne présidentielle suivante. À chaque fois, il s'agit de tirer la manne des grands contrats civils ou militaires. Le durcissement de la législation sur le financement des partis a accouché d'un monstre : désormais, la pratique des rétrocommissions est devenue la règle d'un certain commerce international d'État. Cette « République des mallettes » a pris le pas sur l'État démocratique. Son fonctionnement et les décisions les plus stratégiques du pays semblent aiguillonnés, plutôt que par l'intérêt national, par le souci de perpétuer ce système et de le rendre le plus fluide possible par la constitution d'une oligarchie restreinte occupant les postes « stratégiques » : à la tête des grandes entreprises à capital public, à l'Élysée et dans les ministères régaliens. Une oligarchie pour qui l'argent est devenu roi. À travers l'incroyable itinéraire de l'un des « facilitateurs » de ce système, personnage au passé des plus troubles, Pierre Péan démonte une à une les pièces d'un mécanisme qui, si nous n'y prenons garde, finira par ronger le système démocratique français, comme c'est déjà le cas en Russie ou en Italie. Pierre Péan est enquêteur-écrivain. On lui doit notamment *Affaires africaines* (1983), *Une jeunesse française* (1994) et *Le Monde selon K.* (2008). Il a publié dernièrement aux éditions Mille et une nuits *Carnages*.
